MIXED BREED CLASSES OFFERED

Dogs entered in the mixed breed classes must list the breed name as "mixed breed" and not as a breed hybrid.

Random Draw: All entries will be opened prior to the draw and checked for accuracy. All duplicate entries for the same dog will be declared ineligible and the entry fees forfeited. Entries for a maximum of ten (10) dogs are allowed in each envelope submitted to the Trial Secretary for random draw. Envelopes containing more than the ten (10) entries will be returned.

Awards: All ribbons and rosettes must be claimed at the trial, none will be mailed. Qualifying ribbons will be awarded to all dogs receiving a qualifying score. Rosettes will be awarded to 1st through 4th place dogs in each jump height in each class. Rosettes and bars will be awarded for completion of a MACH or PAX title. Each qualifying run will be offered a raffle ticket for a drawing. Multiple prizes up to \$25.00 each. Any returned rosettes will be exchanged for an additional raffle ticket. Daily drawings.

Eligibility: This trial is open to all dogs over the age of 15 months that are registered with the American Kennel Club or are registrable breeds that have obtained an AKC or ILP/PAL number, and AKC registered mixed breeds, except bitches in season, aggressive dogs, or dogs suffering from any deformity, injury, or illness which may affect the dog's physical or mental performance.

Height Divisions: Owners/agents are responsible for entering the proper height divisions. All height divisions will be offered in both the standard classes and the jumpers with weaves classes. Dogs in the Preferred classes MUST jump in their measured height and may not jump in a higher height or any qualifying scores and placements earned will be disallowed. Therefore, if you are unsure of your dog's correct jump height, please enter the lower height and if necessary your dog will be moved to the higher height.

Notice to Exhibitors

- **Entry fees are \$18 per dog for first entry, \$18 for second entry of same dog, same day; \$10 FAST as third entry of same dog on Friday**
- Telegraph, telephone, fax, and unsigned entries or entries without fees cannot be accepted.
- **Entries not on Official AKC Agility Entry without the Agreement and Rules attached to the Official AKC Entry will NOT be accepted.**
- Express Mail Entries must include signature permitting them to be left at the Secretary's address without recipient's signature.
- Returned or postdated checks do not constitute a valid entry fee. There will be a \$25 service charge for each returned check.
- No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance.
- Owners are responsible for errors in making out entry forms correctly and no entry fees will be refunded in the event of such errors or cancellations of entries after the published closing date.
- The Bouvier des Flanders Club of Southeastern Michigan (BdFCSEM) may decline any entries and may remove any dog on account of disease, viciousness, or other cause and no one shall have any claim against BdFCSEM or any official thereof.
- BdFCSEM will not be responsible for any lost or damaged items left at the show.
- The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Puppies under the age of 6 months are strictly prohibited from the premises.
- Entry fee will not be refunded in the event that the dog is absent, disqualified, excused, or barred from competition by action of judge or show committee.
- Bitches in season will not be admitted to the Trial. Entry fee (minus \$8/day) will be refunded for bitches in heat with a note from a veterinarian. Note must be received before the start of judging.
- **Canadian Exhibitors must make fees payable in US funds. BdFCSEM assumes no responsibility for cash sent through the mail.**
- Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Show Committee, be asked to leave the show site. In such case, no refund of any entry fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- All dogs must be on leash at all times except when in the ring or when in the designated agility warm-up area.
- Obstacles will conform to the requirements in the current edition of the AKC Regulations for Agility Trials.
- **Please clean up after your dog.** Receptacles will be provided.
- Overpayments of fees less than \$10 will be considered a donation to the club and will not be returned.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

AGREEMENT

I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog.

INSTRUCTIONS

Handlers may opt to enter in a higher height division for all Regular titling classes, but not in a division lower than their proper height division. Dogs entered in the Preferred classes must compete at the required jump height and may not compete in a jump height division higher or lower than their proper height division. All dogs that have not been officially measured for an Agility Jump Height Card may still compete; however, they must be measured by a Judge of record, an Agility Field Representative, or a Volunteer Measuring Official, prior to running. If measured by the Judge of record, that measurement will be valid for this trial or back-to-back trials only. If a measurement is necessary, it is the exhibitor's responsibility to have their dog(s) measured prior to running.

Mixed breed classes may only be offered at standalone all-breed AKC agility trials. A standalone agility event is defined as an agility trial that is not held on the same date and show site as an AKC All-Breed Dog Show or Independent Specialty for conformation. Dogs entered in the mixed breed classes must list the breed name as "mixed breed" and not as a breed hybrid.
